# Effectiveness of Using Blackboard in EFL Saudi Secondary Schools

#### $\mathbf{Abstract} \Box$

Blackboard remains one of the most effective approaches that the educational sector in different countries has had to assimilate. Countries such as Saudi Arabia have notably incorporated the use of different types of blackboards in their learning institutions with the primal focus of ensuring that the aspect of education is enriched. Furthermore, according to researchers such as Bradford et al. (2007), the idea of integrating the use of various blackboard within the learning institutions have significantly helped in ensuring that language learning, especially in EFL Saudi Secondary Schools, is enhanced. This study explores the effectiveness of Blackboard tools, particularly Blackboard Collaborate, in enhancing reading and overall learning in EFL Saudi secondary schools. Data were sourced primarily from peer-reviewed journals that examined Blackboard's role in improving various aspects of education, including studies by Heirdsfield et al. (2011), Al-Otaibi (2017), Katsifli (2010), Riley (2013), Cernusca (2008), and Muttappallymyalil et al. (2016). These works were selected based on the credibility of their evidence and relevance to the research theme. Findings indicate that Blackboard platforms not only enrich instruction and facilitate learner-teacher interaction but also provide cost-effective, flexible, and socially engaging learning environments. The integration of Blackboard Collaborate into EFL classrooms in Saudi Arabia is therefore recommended, as it has the potential to expand access to education, foster student engagement, and support lifelong learning while contributing to the overall development of the country's educational landscape.

# فعالية استخدام البلاك بورد في المدارس الثانوية السعودية للغية الإنجليزية كلغية أجنبية

#### بلخـــص

يُعَدّ البلاك بورد أحد أكثر الأدوات التكنولوجية فعالية التي تبنتها القطاعات التعليمية عالميًا. وفي المملكة العربية السعودية، كان لدمجه في المدارس الثانوبة أثر بارز في إثراء عملية التعليم والتعلم. ووفقًا لـ Bradford وآخرين (٢٠٠٧)، فقد أسهم اعتماد منصات البلاك بورد بشكل أساسي في دعم تعلم اللغات، ولا سيما في سياقات تعليم اللغة الإنجليزية كلغة أجنبية .(EFL) تهدف هذه الدراسة إلى استكشاف فاعلية أدوات البلاك بورد - وبشكل خاص Blackboard Collaborate – في تعزيز مهارات القراءة والتعلم بوجه عام في المدارس الثانوبة السعودية. وقد استندت الدراسة إلى مجموعة من الأبحاث المحكمة، منها أبحاث **Katsifli** Al-Otaibi، و(2010) Heirdsfieldوآخربن (۲۰۱۱)، و (2017) و (2013) Riley، و(2008) ernusca (2008)، وCernusca (2008) وآخرين (٢٠١٦)، والتي تم اختيارها بناءً على مصداقيتها وارتباطها بموضوع البحث. وتشير النتائج إلى أن البلاك بورد يثري العملية التعليمية، ويعزز التفاعل بين المعلم والمتعلم، ويوفر بيئات تعلم مرنة وفعّالة من حيث التكلفة وأكثر تفاعلية اجتماعيًا. وبناءً على ذلك، توصى الدراسة بدمج Blackboard Collaborate في فصول اللغة الإنجليزية بالمدارس الثانوية السعودية، لما له من دور في تعزيز تفاعل الطلاب، وتوسيع فرص الوصول إلى التعليم، ودعم التعلم مدى الحياة، بما يسهم في تطوير المشهد التعليمي الوطني.

With the recent technological advancement, different aspects of our social lives especially education have significantly been promoted to a whole new perspective. #### **Literature Review**

According to sources such as Muttappallymyalil's (2016) peerreviewed journal, blackboard has for the past few years been categorized as one of the most effective and more essential approaches that have significantly helped in the transformation of the learning environment to a whole new perspective. The attestation could be elucidated further considering that the application of such forms of learning has made reading more manageable and effective to all learners. Besides, the approach has notably been associated with services that have similarly helped in ensuring that the learning environment is more accessible despite one's geographical locality. In addition, Blackboard-based teaching aligns with constructivist and student-centered approaches, thereby encouraging equal involvement and active engagement from all learners (Motlhaka, 2020).

According to Dhawan (2020), the World Economic Forum (WEF) stressed the importance of preparing individuals for challenging circumstances, since the COVID-19 pandemic forced many to re-evaluate their outlook on education. To address difficult circumstances, educational institutions provided detailed guidance for teachers and learners, which supported the shift and enabled broader engagement with online learning via Learning Management System (LMS) platforms (Yen, 2020).

Blackboard Collaborate is on the other hand considered beneficial bearing the fact that it helps in accommodating multiple reading and learning styles. Like other online learning practices, the use of Blackboard Collaborate is deemed to be beneficial bearing the fact that it helps in promoting varied learning style within the learning institution. Rona Besijeta's (2013) article notes that blackboard tools are considered beneficial particularly in providing information that advances a student's knowledge and skills. While reviewing the application of tools such as Blackboard Collaborative web, one would note that the tool offers a wide range of platforms whereby students could use to help in advancing their knowledge on concepts that are typically taught in class. One of these platforms notably regards to online library whereby a student is allowed to conduct further research on different sources including books and journals that are useful and related to the lessons taught in class. Therefore, through the availability of such platforms students are able to gain an in-depth understanding of the concepts being taught in class which offers them more in-depth knowledge while still taking these course. With this attestation, its right to attest to the fact that incorporating online learning tools such as Blackboard Collaborative is not only beneficial towards enhancing communication amid the learners and the teachers but also an effective way while aiming to advance student's knowledge and skills. Still, like other technologies, Blackboard does not ensure educational success on its own; its effectiveness depends on careful planning, proper use, and supportive strategies. The idea of indulging in learning practices through online tools have significantly

helped in promoting both the social, political, and even the cultural lives of these students bearing the fact that these platforms offer an effective way of learning and socializing. Therefore, with this attestation, one can no doubt attest to the fact that learning tools such as Blackboard Collaborate regard to one of the best and most effective ways of learning that should be adopted and utilized in all learning institutions. Furthermore, the only difference between traditional methods of learning and such modern methodologies centres on the fact that these forms of learning do not indulge in face-face learning. Besides, while assessing the advantages and disadvantages associated with the incorporation of this form of learning, one would no doubt attest to the fact that the benefits emanating from the integration of the approach outweigh the disadvantages.

situated in Saudi Arabia. Other articles used in articulating the research notably include DemetraKatsifli's (2010) article, Alanna Riley's (2013) research article, Dan Cernusca's (2008) article which is categorically focused on explaining how to effectively use Blackboard, and Muttappallymyalil et al. (2016) article which is notably focused on elaborating more on the evolution of technology in teaching specifically through Blackboard services.

While assessing credible articles to be applied in this research, several aspects were notably considered. A major factor that was considered while reviewing the articles relates with the information or the data used in articulating the research. In regard to the factor of information, analysis was first conducted to identify articles with detailed information regarding the research's primal thematic context.
